Kindly refer to this office letter mentioned above , wherein approval of competent authority was conveyed for provision of 645 broadband connections with Start up plan in the cities allocated to M/s SDPL (IPTV Franchisee for the cities enclosed).

In modification of the orders issued earlier, the approval of competent authority is hereby accorded for collection of charges as follows for these 645 broadband connections:

1. Installation charges(One time) : Rs 500/- per connection
2. Security deposit (one time , refundable) : Rs 500/-
3. Monthly charges : Rs 300/- per connection
4. Monthly Modem charges : 80(for Type II) per connection

The internet access may be blocked for this case as users are only allowed to access IPTV services.

It has been decided that a landline connection may also be provided with only incoming facility with the Broadband connection under Sulabh Plan with zero rental. All existing commercial terms & conditions under Sulabh Plan would be applicable.
